14 The above entitled matter came regularly before this court
15 for trial on March 19, 1990. The plaintiff and the defendant
16 appeared for trial.

17 The Court has reviewed the exhibits and interrogated the
18 plaintiff and defendant and finds:

19 That the plaintiff brought an action against the defendant
20 in the Municipal Court, Los Angeles, California. The defendant
21 appeared in the action by filing an answer to plaintiff's
22 complaint and submitted himself to the jurisdiction of the
23 California Municipal Court.

24 The defendant's answer is without merit and plaintiff is
25 entitled to judgment.

26 NOW, THEREFORE, plaintiff is awarded judgment against the
27 defendant for the principal sum of SEVENTEEN THOUSAND FIVE HUNDRED
28 DOLLARS (\$17,500.00), together with accrued interest in the sum of

1 SIX THOUSAND ONE HUNDRED SIXTY TWO DOLLARS AND FIFTY CENTS
2 (\$6162.50), costs of suit in the sum of FIVE HUNDRED SIXTY NINE
3 DOLLARS AND NINETY ONE CENTS (\$569.91), and attorneys fees in the
4 sum of \$ 1200⁰⁰. That all sums except accrued interest shall
5 bear interest at the rate of 10% per annum until paid in full.

6 That plaintiff's bond of \$500.00 as security for costs is
7 hereby exonerated.
