STIPULATION AND ORDER  
FOR ENTRY OF JUDGMENT

IT IS HEREBY STIPULATED AND AGREED by and  
between the parties hereto; the Defendant being advised  
of his right to counsel:

1. That Defendant is the father of the  
following named minor child, and had the duty and ability  
to support said dependant:

AARON PEARSON born October 12, 1972.

2. That Defendant has received filed copies of  
the pleadings herein, and understands the contents of the  
same.

3. That Defendant agrees that his support  
obligation should be in the sum of SEVENTY-TWO DOLLARS  
(\$72.00) per month, payable on the first day of each and  
every month, commencing on January 1, 1990, and continuing  
thereafter until the child attains the age of majority,  
dies, marries, or is other emancipated.

4. That Defendant agrees that the arrears due  
Plaintiff are in the sum of THIRTEEN THOUSAND SIX HUNDRED

1 FIFTY DOLLARS (\$13,650.00) and that judgment be entered for  
2 said amount. Defendant further agrees to pay the sum of ONE  
3 HUNDRED TWENTY-EIGHT DOLLARS (\$128.00) toward these arrears,  
4 payable the first day of each and every month commencing  
5 January 1, 1990, and continuing until said judgment amount  
6 is paid in full. Defendant further agrees to increase  
7 payment toward arrears to TWO HUNDRED DOLLARS (\$200.00) per  
8 month when AARON PEARSON is emancipated.

9 5. That Defendant understands that a mandatory  
10 wage or income withholding will be initiated against his  
11 wages or commission pursuant to NRS 130.220. This does not  
12 preclude the use of other means of execution to collect the  
13 arrearages.

14 WHEREFORE, THE PARTIES RESPECTFULLY REQUEST that the  
15 above-entitled Court enter its Order in conformance with the  
16 Stipulation hereinabove, and that this Court further order  
17 that Defendant make his payments in the form of Cash, Money  
18 Order, Cashier's Check, or Certified Check made payable to  
19 the "LYON COUNTY DISTRICT ATTORNEY", and mailed or delivered  
20 to the Lyon County District Attorney, 31 South Main Street,  
21 Yerington, Nevada 89447, for transmission by that office to  
22 Plaintiff above-named.
