20 AFTER CONSIDERING ALL OF THE EVIDENCE, THE COURT FINDS:

- 21 1. That the Court has jurisdiction of the parties and
22 subject matter of this case.
- 23 2. That the defendant/respondent is the parent of the
24 following child/ren:
CHELSEA MARIE JIBSON Born: June 3, 1989
- 25 3. That the defendant/respondent owes a duty of support to
26 the following dependent/s:
CHELSEA MARIE JIBSON Born: June 3, 1989
- 27 4. That \$200.00 per month is a reasonable amount of support
28 for defendant/respondent to pay.

- 1 5. That the defendant/respondent is in arrears in the
 2 amount of \$1,000.00 for the period January 10, 1990,
 3 through May 31, 1990.
- 4 6. That the defendant owes reimbursement to Nevada State
 5 Welfare Division in the amount of \$350.00 for paternity
 6 blood testing.
- 7 7. The Court further finds that:

(1) The defendant has agreed by stipulation to
 pay \$25.00 per month first toward satisfaction of
 his \$350.00 debt for paternity blood testing until
 paid in full, and thereafter toward satisfaction of
 his \$1,000.00 child support arrearage.

THEREFORE, IT IS HEREBY ORDERED THAT:

- 10 1. That the defendant/respondent is the parent of the
 11 following child/ren:
 12 CHELSEA MARIE JIBSON Born: June 3, 1989
- 13 2. Judgment is entered in favor of plaintiff JANIS F.
 14 JIBSON and against defendant in the amount of
 \$1,000.00 for child support arrearages through and
 including May, 1990.
- 15 3. Judgment is entered in favor of Nevada State Welfare
 16 Division and against defendant in the amount of \$350.00
 as reimbursement of paternity blood testing.
- 17 4. The defendant shall reimburse plaintiff for one-half of
 18 all unreimbursed medical expenses incurred on behalf of
 his minor child CHELSEA MARIE JIBSON.
- 19 5. That the defendant shall reimburse plaintiff for one-half
 20 of medical insurance premium cost for his minor child in
 the amount of \$49.18 per month.
- 21 6. That defendant/respondent shall pay \$274.18 per month,
 22 beginning June 15, 1990, to be paid as follows:

- 25 7. The defendant/respondent shall notify the Court of any
 26 change of address/employment within 10 days.

1 8. It is further ordered that:

2 (1) Defendant's \$274.18 monthly child
3 support obligation shall be due on the 15th day of
4 June, 1990, and shall continue due on the 15th
5 day of each month thereafter until further order
6 of this Court.

7 (2) That when defendant's minor child/ren
8 emancipate/s, defendant shall continue to pay
9 \$200.00 per month toward satisfaction of then
10 existing child support arrears.

11 (3) That defendant's ordered \$25.00 monthly
12 payment on child support arrearages does not
13 preclude other methods of collection for child
14 support arrears.

15 (4) This support order shall be reviewed every
16 three years in accordance with NRS 125B.145.

17 (5) That defendant's monthly child
18 support payments shall be in the form of a
19 cashier's check, certified check, or money order,
20 or in cash. If the payment is in the form of cash,
21 it must be delivered to the Douglas County Clerk at
22 her office in Minden, Nevada. If the payment is in
23 the form of a cashier's check, certified check, or
24 money order, it must be made payable to the
25 DOUGLAS COUNTY CLERK, must contain the notation
26 Case No. 22758 (BREWER), and be either mailed to
27 the Douglas County Clerk at Post Office Box
28 218, Minden, Nevada 89423, or delivered to said
County Clerk at her office in Minden,
Nevada. The Douglas County Clerk shall
transmit said payments to JANIS F. JIBSON, P.O. Box
1148, Minden, NV 89423.

9. NOTICE: This is an income withholding order. Support
payments in arrears by 30 days may be withheld from income
without further order of any court or further application
for services.
