thereof.


SUBJECT TO any and all matters of record, including taxes, assessments, easements, oil and

unto the said Grantee and their assigns forever.



EXHIBIT "A"

RIDGE CREST LEGAL

A Timeshare estate comprised of:

PARCEL 1: An undivided 1/51st interest in and to that certain condominium estate described as follows:
