THIS AGREEMENT, dated June 7, 1990, is made and entered into by and between the County of Alpine, California, and the Douglas County Paramedic Ambulance District, Douglas County, Nevada.

WITNESSETH

WHEREAS, the Douglas County Paramedic Ambulance District maintains a twenty-four hour ambulance service; and

WHEREAS, the County of Alpine, California, is in need of paramedic ambulance services and desires to make use of the Douglas County Paramedic Ambulance District paramedic ambulance service; and

WHEREAS, the Douglas County Paramedic Ambulance District is willing to provide said service for fiscal year 1990-91, in accordance with the considerations and condition listed herein.

NOW, THEREFORE, IT IS AGREED by the parties hereto as follows:

1. The County of Alpine, California, is authorized by the Douglas County Paramedic Ambulance District to use it's contracted ambulance services within the geographic limits defined herein during fiscal year 1990-91.
2. For the use of said services the County of Alpine shall pay to the Douglas County Paramedic Ambulance District:
  - A. A basic annual fee of Five Thousand Dollars (\$5,000), and
  - B. An annual subsidy payment of Nine Thousand Dollars (\$9,000).
3. The County of Alpine, California, shall pay the Douglas County Paramedic Ambulance District for all ninety (90) day delinquent or uncollectible ambulance invoices for services rendered in or requested from the County of Alpine, California. Upon payment the Douglas County Paramedic Ambulance District shall assign all of it's rights to said delinquent invoices to the County of Alpine, California.

4. The geographic response limits of the Douglas County Paramedic Ambulance District paramedic ambulance shall be:

A. California State Route 4 from the intersection of Wolf Creek Road to the end at Woodfords, California, including the Wolf Creek area.

B. California State Route 88 from the intersection of Picketts Junction in Hope Valley to the California/Nevada state line.

C. California State Route 89 (Monitor Pass) from the intersection of California State Route 4 to the Mono County line.

5. The County of Alpine shall defend, save harmless and indemnify the Douglas County Paramedic Ambulance District, the district's employees and the Douglas County Paramedic Ambulance District Commission from all liabilities and claims for damages arising out of the performance of this agreement.

6. The Douglas County Paramedic Ambulance District shall furnish evidence of liability insurance to the County of Alpine.

7. All payments to be made by the County of Alpine to the Douglas County Paramedic Ambulance District shall be made as quarterly installments. The first such payment shall be due and payable on execution of this agreement; the second such payment on October 1, 1990, the third and fourth such payments shall be due and payable on January 1, 1991 and April 1, 1991, respectively. Any amounts provided for in Paragraph 3 and 4 which are determined after April 1, 1991, shall be paid by the County of Alpine when billed.


