Pursuant to NRS 111.460, this power of attorney is not affected by disability of the principal.

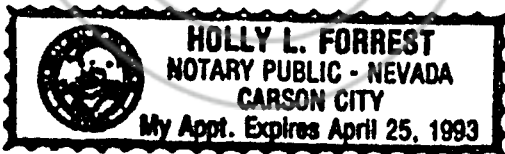

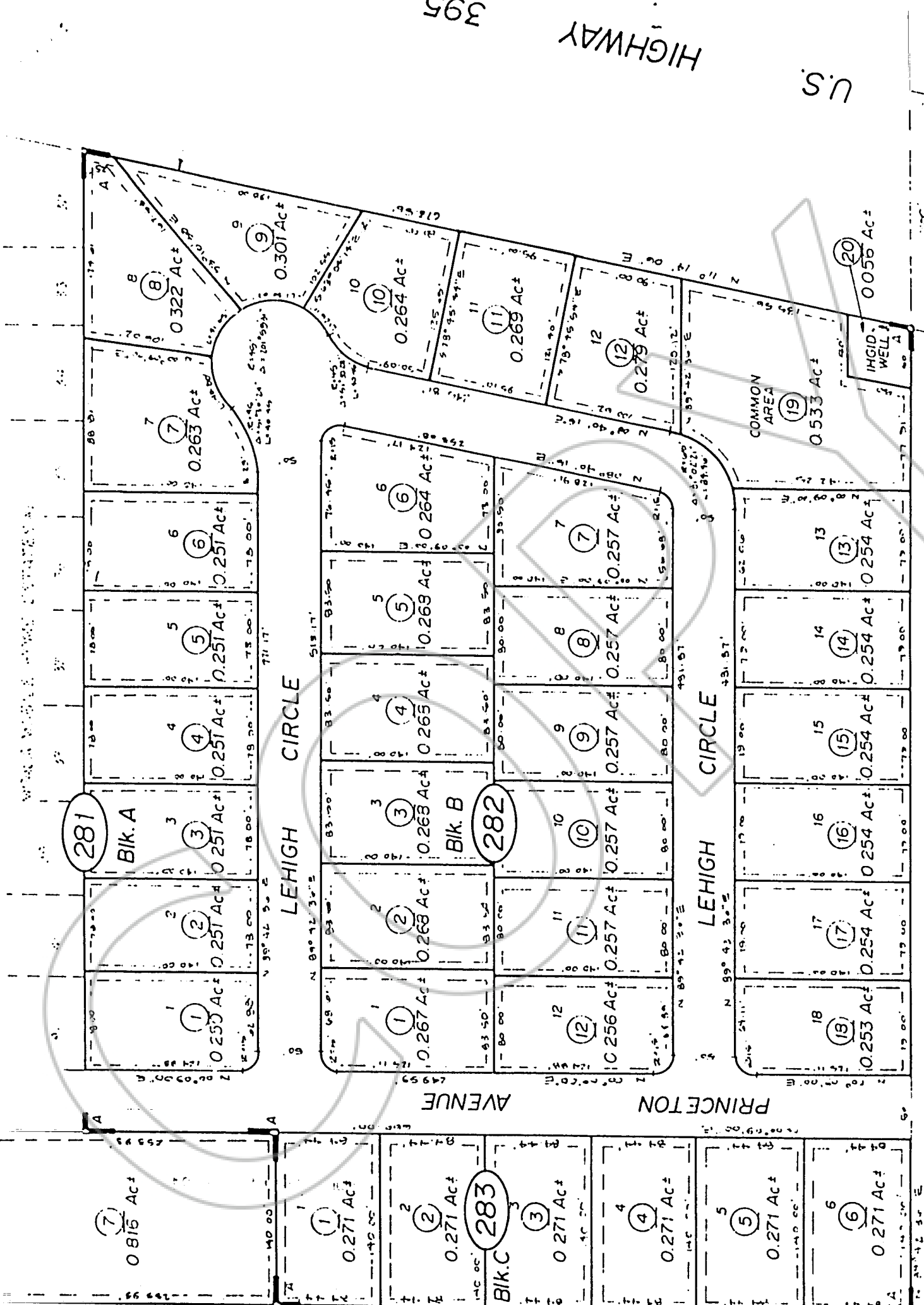
