## RELEASE AND COVENANT NOT TO SUE

Carson Valley Discount Tire, Inc., and Henry Byers (collectively the "Owners") own certain adjacent parcels of real property at or near 1469 U.S. Highway 395, Gardnerville, Nevada. One or both of these parcels has two old structures which the Owners wish to have demolished. The Owners warrant that there are no liens or encumbrances against these structures which would prevent their demolition. Accordingly, the Owner's grant to the East Fork Fire Protection District ( "East Fork") permission to conduct fire training exercises on January 13 and 14, 1990, within the structures. The Owners also grant to East Fork permission to conduct fire training exercises through June 1, 1990, in the smaller structure. The Owners understand that these fire training exercises will result in the demolition by fire of the structures.

In consideration of the foregoing, the Owners agree to indemnify and hold harmless East Fork, Douglas County, and the members of the volunteer fire departments participating in these fire training exercises, and all their agents, heirs, and assigns, from any claims made by third parties, as a result of any liens upon the structures, whether recorded or not, and for any other claims for damage of whatever nature, which may be raised against the parties as a result of the loss of the structures as a consequence of the fire training exercise.

The Owners further understand that these fire training exercises will involve the use of fire, fire training equipment, and large quantities of water and other fire suppressants. Finally, the Owners hold East Fork, Douglas County, and the members of the volunteer fire departments and their agents, heirs, and assigns harmless for any damage which may result to the property from these fire training exercise.

East Fork hereby indemnifies and holds harmless Owners from any claims of damage made by surrounding property owners which arise as a result of the negligence of East Fork in conducting the fire training exercises.


