AMENDMENT NO. 1 TO GRANT AGREEMENT FOR PROJECT NO. 3-32-0013-03

WHEREAS, the Federal Aviation Administration, (hereinafter referred to as the "FAA"), has determined it to be the interest of the United States that the Grant Agreement between the FAA, acting for and on behalf of the United States, and the County of Douglas, Nevada, (hereinafter referred to as the "Sponsor"), accepted by said Sponsor on the 16th day of September, 1988, to be amended as hereinafter provided.

NOW THEREFORE, WITNESSETH:

That in consideration of the benefits to accrue to the parties hereto, the FAA, acting for and on behalf of the United States of America, on the one part, and the Sponsor, on the other part, do hereby mutually agree as follows:

That the maximum obligation of the United States as set forth in Paragraph 1 of the terms and conditions, Conditions, on page 2 of said Grant Agreement, is hereby increased by \$29,748.16 from \$815,447.00 to \$845.195.16.

IN WITNESS WHEREOF, the parties hereto have caused this Amendment to said Grant Agreement to be duly executed as of the 21st day of September, 19 90.
