22 AFTER CONSIDERING ALL OF THE EVIDENCE, THE COURT FINDS:

- 23 1.  That the Court has jurisdiction of the parties and  
subject matter of this case.
- 24 2.  That the defendant/respondent is the parent of the  
25 following child/ren:

- 27 3.  That the defendant/respondent owes a duty of support to  
the following dependent/s:

- 1 4.  That \$306.00 per month is a reasonable amount of support  
2 for defendant/respondent to pay.
- 3 5.  That the plaintiff does not want the Douglas County  
4 District Attorney's Office to enforce an order for  
5 ongoing child support
- 6 6.  That the defendant/respondent owes reimbursement in the  
7 amount of 2,779.00 as of September 28, 1990.
- 8 7.  That the Defendant owes reimbursement to plaintiff  
9 Nevada State Welfare Division for paternity blood testing  
10 in the amount of \$466.00.
- 11 8.  The Court further finds that:  
12 (1) The defendant has agreed by stipulation to  
13 pay \$200.00 per month toward satisfaction of  
14 reimbursement owed to plaintiff referred to in  
15 Findings No. 6 and 7.

THEREFORE, IT IS HEREBY ORDERED THAT:

- 16 1.  That the defendant/respondent is the parent of the  
17 following child/ren:

- 20 2.  Judgment is entered in favor of plaintiff/petitioner  
21 Nevada State Welfare Division and against Defendant  
22 in the amount of \$466.00 for paternity blood testing.
- 23 3.  Judgment is entered in favor of plaintiff/petitioner  
24 Nevada State Welfare Division and against Defendant  
25 in the amount of \$2,779.00 for reimbursement.
- 26 4.  That defendant/respondent shall pay \$200.00 per month,  
27 beginning October 20, 1990, to be paid as follows:

6 change of address/employment within 10 days.
- 7 6.  It is further ordered that:

9       (1) That defendant's first \$200.00  
10 reimbursement payment shall be due on October 20,  
11 1990, and shall continue due on the first day of  
12 each and every month thereafter until further order  
13 of this court.

1 (2) That defendant's ordered \$200.00 monthly  
2 payment on child support reimbursement does not  
3 preclude other methods of collection for child  
4 support arrears.

5 (3) This support order shall be reviewed every  
6 three years in accordance with NRS 125B.145.

7 (4) That defendant's monthly child  
8 support payments shall be in the form of a  
9 cashier's check, certified check, or money order,  
10 or in cash. If the payment is in the form of cash,  
11 it must be delivered to the Douglas County Clerk at  
12 her office in Minden, Nevada. If the payment is in  
13 the form of a cashier's check, certified check, or  
14 money order, it must be made payable to the  
15 DOUGLAS COUNTY CLERK, must contain the notation  
16 Case No. 22887 (MCDONALD), and be either mailed to  
17 the Douglas County Clerk at Post Office Box  
18 218, Minden, Nevada 89423, or delivered to said  
19 County Clerk at her office in Minden,  
20 Nevada. The Douglas County Clerk shall
