ORDER SETTLING FIRST ACCOUNT
AND REPORT OF CO-EXECUTRIXES,
CONFIRMING PAYMENT OF
ATTORNEY'S FEES AND FOR FINAL
DISTRIBUTION OF ESTATE

BE IT REMEMBERED that KATHLEEN D. TUTT and KIMBERLEE A. TUTT, Co-Executrixes of the Last Will and Testament of GRACE JEANNE TUTT, deceased, filed herein on the 26th day of October, 1990, a First and Final Account and Report of Co-Executrixes and Petition for Settlement Thereof, for Allowance of Attorney's Fees and for Final Distribution, and the Court having considered the same and having examined the evidence in this matter, finds that proper notice has been given in this matter; that all allegations in said account and petition are true and correct; and all obligations of this estate have been fully paid or will be paid, except for certain administrative costs and expenses to be hercin allowed; that after allowance and payment of the aforesaid administration costs and expenses, this estate will be in a condition to be finally settled and distributed to the beneficiaries hereinafter named,

THEREFORE, IT IS ORDERED, ADJUDGED AND DECREED:

1. That the First and Final Account of KATHLEEN D. TUTT and KIMBERLEE A. TUTT, as Co-Executrixes of the Last Will and Testament of GRACE JEANNE TUTT, deceased, be, and the same is, hereby finally settled, allowed, and approved, and all actions taken by the Co-Executrixes in connection with the administration of the estate as set forth in the account and petition filed herein on

1 October 26, 1990, are hereby ratified and approved.

2 2. That the payment of fees to JAMES M. O'REILLY, ESQ. by the California estate in the
3 amount of FOUR THOUSAND DOLLARS (\$4,000) is hereby confirmed.

4 3. That said Co-Executrixes are hereby authorized and directed to pay and distribute all the
5 rest and residue of the decedent's estate, including that real property located in Douglas County,
6 Nevada, more particularly described as follows:

7 Lot 354, as said lot is shown on the Official Plat of GARDNERVILLE RANCHOS
8 UNIT NO. 2, filed in the office of the County Recorder of Douglas County, Nevada,
9 on June 1, 1965 in Book 1 of Maps, filed as No. 28309, and Title Sheet amended on
10 June 4, 1965, as Filing No. 28377.

12 together with any other property not now known or hereafter discovered, to KIMBERLEE A. TUTT.

13 4. That the Court does hereby retain jurisdiction of the above-entitled estate until the same
14 shall be distributed and closed, and that upon said Co-Executrixes showing that they have delivered up
15 all the remaining property of the estate to the beneficiaries entitled thereto, that a decree of discharge
16 shall be entered and filed discharging said Co-Executrixes from all liability thereafter to be incurred.
