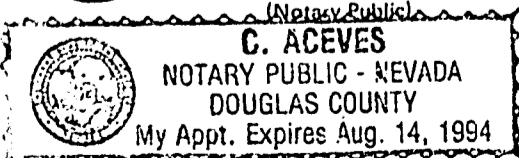

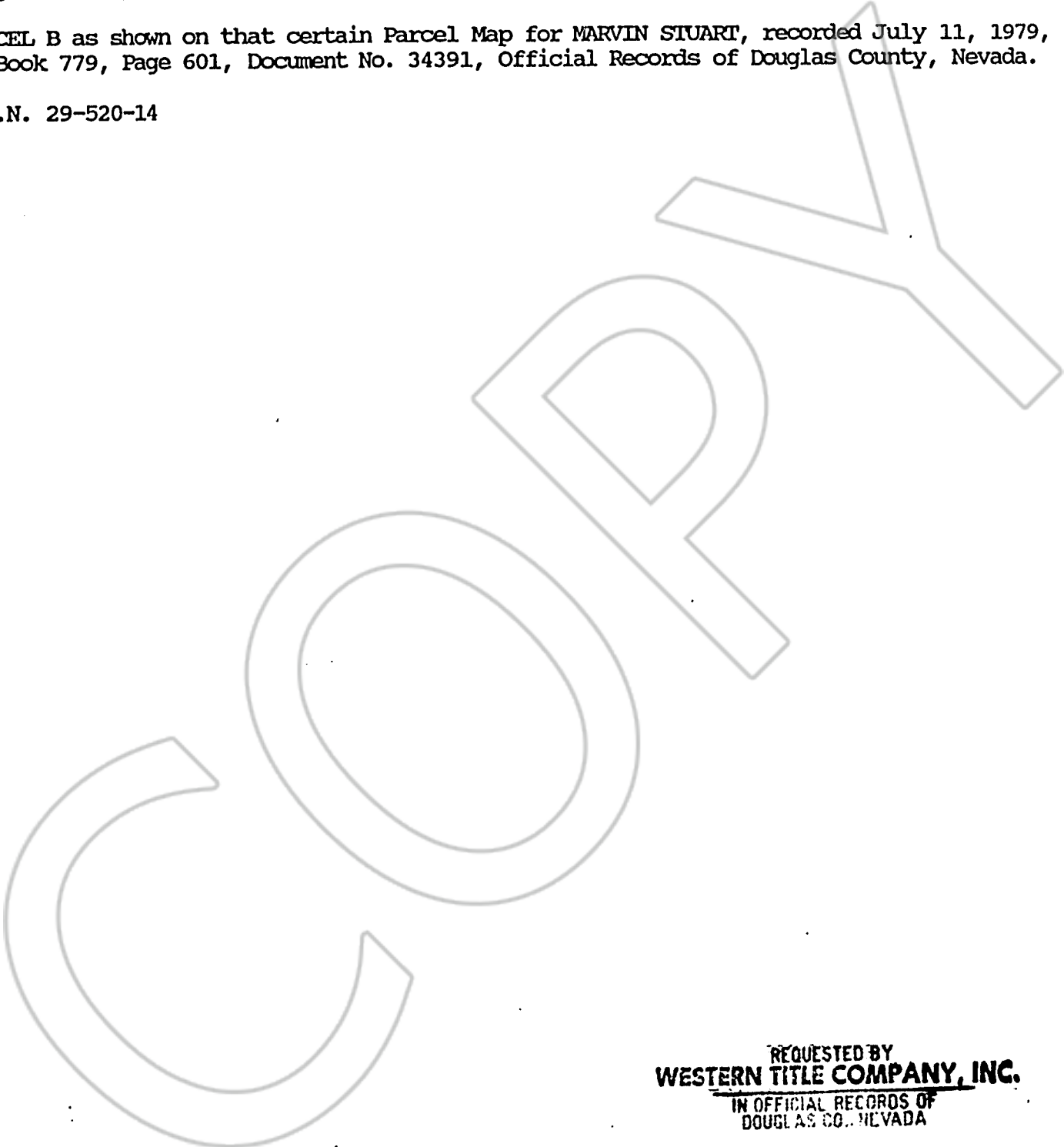
DESCRIPTION
