THIS AGREEMENT is made this of day of CLERK
1990, between Douglas County, whose address is Bost Office Box
218, Minden, Nevada 89423, and Advanced Data Systems, Inc.
("ADS") whose address is 300 Hot Springs Road, Suite 21, Carson
City, Nevada 89706.

In consideration of the mutual promises by ADS and Douglas County the parties agree as follows:

- 1. ADS agrees to perform the following services by December 31, 1990:
- A. Convert the existing ADS state budgeting system to Douglas County's native AS 400, including replacement of System 36/OCL with AS/400 CL, all files "externally" defined and the creation of a system-wide "field reference" file.
- B. Modify the existing programs or write programs to interface the budgeting system with Douglas County's existing New World Systems accounting system.
- C. Install the programs and train county personnel in its use.
- 2. ADS warranties that any program or modified program it provides will work in a manner to serve its stated

purpose. ADS will correct at its cost any program defects or "bugs" in the programs provided or modified that are detected and ADS is notified of it in writing within one year of the acceptance of the program by Douglas County.

- 3. ADS will provide source and object code for the programs or modifications to Douglas County which will have exclusive license to use the codes in any manner it wishes for Douglas County purposes.
- 4. Douglas County agrees to pay up to \$4,800.00 on the following schedule:
- A. \$2,500.00 for conversion and installation of the ADS state budgeting system in Douglas County's AS/400.
- B. \$1,800.00 for modification or writing and installation of programs to interface the existing Douglas County accounting system with the ADS budget program.
- C. \$500.00 for completion of training and acceptance of the programs by Douglas County after demonstration that software works properly.
- 5. The parties agree that if the State changes its budgeting system during the time of the contract or year warrantee period that Douglas County may request modification

of the software provided by ADS. The cost of modification shall be for labor and materials to ADS.

- Douglas County and ADS agree that time is of the essence.
- ADS agrees that after the first year that it will propose cost and time frame for a maintenance agreement for maintenance and any state mandated changes.
