GIFT DEED

W I T N E S S E T H:

That Grantors, for and in consideration of the sum of ONE DOLLAR (\$1.00) and other good and valuable consideration and the love and affection had and borne by Grantors for Grantee, receipt of which is hereby acknowledged, do by these presents Grant, Bargain and Sell unto Grantee, their heirs, successors and assigns forever, one-half (1/2) of Grantors' interest in all that certain real property situate in the County of Douglas, State of Nevada, described as follows:

TO HAVE AND TO HOLD, all and singular, the said premises together with the appurtenances, unto Grantee, and to his heirs and assigns forever.

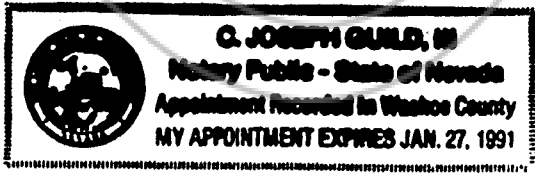
