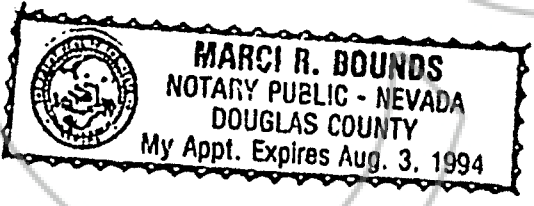

**LEGAL DESCRIPTION**  
(Wildhorse Unit 4)

A portion of the West 1/2 of Section 33, Township 14 North, Range 20 East, M.D.N. & M. in the County of Douglas, State of Nevada, being more particularly described as follows:

Beginning at the Northeasterly corner of Lot 25 of Wildhorse Unit 1, as said subdivision is recorded in Book 889 at Page 450 as Document No. 207982, Official Records of said Douglas County, said corner being on the Westerly right-of-way line of Vicky Lane (80.00 feet wide, measured at right angles); thence N. 89° 54' 00" W., 282.39 feet; thence N. 78° 54' 00" W., 355.00 feet; thence N. 1° 17' 57" E., 153.00 feet; thence N. 83° 20' 36" W., 285.00 feet to a point on a curve concave to the West and having a radius of 1510.00 feet, a radial line through said point bears N. 89° 47' 09" E.; thence Northwestwardly along said curve through a central angle of 12° 17' 14", an arc distance of 323.82 feet to a point on said curve, a radial line through said curve bears N. 77° 29' 55" E.; thence N. 75° 31' 22" E., 437.67 feet; thence N. 6° 35' 45" E., 58.79 feet; thence N. 15° 01' 38" W., 59.05 feet; thence N. 72° 59' 38" E., 141.13 feet; thence Northeasterly along a radial line N. 74° 52' 20" E., 50.00 feet to a point on a curve, said curve being concave to the Southwest and having a radius of 352.00 feet; thence Northerly and Westerly along said curve through a central angle of 8° 20' 53", an arc distance of 51.29 feet to a point on said curve, a radial line through said point bears N. 66° 31' 27" E.; thence N. 66° 00' 54" E., 195.00 feet; thence N. 72° 38' 03" E., 123.91 feet; thence S. 89° 54' 00" E., 70.00 feet to a point on the Westerly line of said Vicky Lane; thence Southerly along said Westerly line S. 0° 06' 00" W., 1234.72 feet to the POINT OF BEGINNING.
