2 NOTICE IS HEREBY GIVEN that PACIFIC COAST BUILDING PRODUCTS, INC., a
3 California corporation, doing business as PACIFIC SUPPLY, the lienor herein, has and asserts a
4 valid claim, after deducting all just credits and offsets, in the amount of FIFTY THOUSAND
5 FOUR HUNDRED FORTY AND 97/100 DOLLARS (\$50,440.97), said amount being the agreed
6 price for building materials and supplies which were used in the construction, alteration and
7 improvements of the premises situated in the County of Douglas, State of Nevada, known as High
8 Sierra Hotel and Casino, Stateline, Nevada.

9 That the owner or reputed owner of said real property is WIMAR TAHOE
10 CORPORATION.


11 That the name of the company to whom PACIFIC COAST BUILDING PRODUCTS, INC.,
12 a California corporation, doing business as PACIFIC SUPPLY, furnished building materials and
13 supplies is WIMAR TAHOE CORPORATION.


