2 (1) In an order entered January 12, 1990,
3 defendant was ordered to pay \$25.00 per month toward
4 satisfaction of child support arrears in the amount
5 of \$450.00.

6 (2) Defendant has paid \$175.00 through
7 February 13, 1991, and the sum of \$275.00 remains
8 owing on the judgment through February 13, 1991.
9 Defendant is currently under a wage withholding for
10 \$25.00 per month.

11 THEREFORE, IT IS HEREBY ORDERED THAT:

12 1. That the defendant is the parent of the following

15 2. Judgment is entered in favor of plaintiff DEBBIE

5. The defendant/respondent shall notify the Court of any
change of address/employment within 10 days.

8. IT IS FURTHER ORDERED THAT:

(1) Defendant's \$25.00 monthly child support obligation shall be due on the 1st day of March, 1991, and shall continue due on the 1st day of each month thereafter until further order of this Court.

(2) That defendant's ordered \$25.00 monthly payment on child support arrearages does not preclude other methods of collection for child support arrears.

(3) That when this order is entered and approved by the District Court, the defendant's property is subject to actions for collection, including, but not limited to, withholding of wages (NRS 31A), garnishment, liens, execution on real or personal property and the attachment of federal income tax refunds.

(4) That, when defendant is unemployed or self-employed, than defendant's monthly child support payments shall be in the form of a cashier's check, certified check, or money order, or in cash. If the payment is in the form of cash, it must be delivered to the Douglas County Clerk at her office in Minden, Nevada. If the payment is in the form of a cashier's check, certified check, or money order, it must be made payable to the DOUGLAS COUNTY CLERK, must contain the notation Case No. 890181 (SANTURRI), and be either mailed to the Douglas County Clerk at Post Office Box 218, Minden, Nevada 89423, or delivered to said County Clerk at her office in Minden, Nevada. The Douglas County Clerk shall transmit said payments to: SAN BERNARDO PROBATION, 175 W. 5th Street, San Bernardino, CA 92415 (Case No. 22542).

9. NOTICE: This is an income withholding order.
