ARTICLE ONE. TRUST ESTABLISHED.

(a) We, CECIL D. ABBOTT and NORA C. ABBOTT, hereafter referred to as the "settlors" or the "trustees", declare that we are husband and wife, and we have hereby set aside and hold in trust all the property described in Schedule A attached hereto.

This trust is a revocable living trust, and shall be known as THE ABBOTT FAMILY 1991 TRUST.

(b) THE TRUST ESTATE.

- 1) SCHEDULE A. All property subject to this instrument from time to time, including the property listed in Schedule A, appended hereto, is referred to as the trust estate, and shall be held, administered, and distributed according to this instrument.

- 5) RETURN TO COMMUNITY PROPERTY. 
