ADMINISTRATIVE ORDER

This matter was heard on MAY 3, 1991 before the Administrative Hearing Officer with the following persons present:

After considering all of the evidence, the Hearing Officer finds:

1. That there is jurisdiction over the parties and subject matter of this case.
2. That the Defendant is the FATHER of:
BRIAN LEE MAEHLER DOB 5/11/77 (per 9/7/90 stip-Δ has custody)
JOLENE MARIE MAEHLER DOB 2/21/79
3. That the defendant has a duty to support the above named children.
4. Pursuant to []NRS 425, []NRS 125B. _____, [x] an existing Order, the defendant owes \$ 173 per month, per child in child support.
5. The defendant owes \$ 3698 through 4/30/91 in arrears.
6. Defendant will maintain medical health insurance when available at a reasonable cost.

THEREFORE IT IS HEREBY ORDERED THAT:

1. Defendant will pay \$ 173 per child, per month for child support beginning NLT 5/31/91, and shall continue due on that date of each month thereafter until further order of this Court.
2. Judgment is entered against the Defendant in the amount of \$ 3698.00 through 4/30/91 as Child Support arrears and Defendant will pay \$ 22 per month to retire said arrears in child support, beginning NLT 5/31/91.
3. Defendant will secure and maintain medical health insurance on the above named children when available at a reasonable cost.
4. Income withholding will be issued immediately unless good cause is stipulated.

(Good Cause exists; implement withholding only if Δ becomes 30 days delinquent in any payment ordered herein)

5. It is further ordered that _____

- 6. Pursuant to NRS 125B.145 this order when issued may be reviewed every three (3) years and is subject to future modifications.
- 7. When the order is entered and approved by the District Court the Defendant's property is subject to actions for collections, including, but not limited to: withholding of wages (NRS 31A), garnishment, liens and the attachment of federal income tax refunds.
- 8. Objections to this order may be filed with the District Court and served upon the other party within ten (10) days of receipt of Order.
- 9. Defendant will forward all payments to the: DOUGLAS COUNTY CLERK, P.O. BOX 218, MINDEN, NV. 89423, and is responsible to notify them of any change of address or employment. Personal checks will not be accepted. Payments shall be in the form of cashier's check, certified check, money order or in cash. If payment is in the form of cash, it must be delivered to the Douglas County Clerk's Office in Minden, Nevada. The following case number will be placed on each payment: 900211.
