AGREEMENT FOR AIRPORT CONSTRUCTION

THIS AGREEMENT, made and entered into the 2nd day of July 1991, by and between the County of Douglas of the State of Nevada, hereinafter called "COUNTY", and T.E. Bertagnolli & Associates hereinafter called "CONTRACTOR".

WITNESSETH

WHEREAS the COUNTY secured bids for airport improvements know as: Improvements, AIP Project No. 3-32-0013-04 and;

WHEREAS the CONTRACTOR submitted a proposal for said improvements which is attached hereto and made a part hereof, said proposal having been regularly and duly accepted by minute order of the Douglas County Board of Commissioners on the eighteenth day of JULY, 1991, all in full compliance with the Contract Documents.

Now, THEREFORE, in consideration of the Mutual Covenants, herein contained, the parties hereto mutually covenant agree to abide as follows:

SCOPE OF WORK

The CONTRACTOR agrees to furnish all labor, materials, tools, and equipment required to perform and complete in good workmanship-like manner the work as called for, in the manner designated in and in strict conformance with the Contract Documents and entitled Specifications and Bid Documents for the Construction of Improvements at Douglas County Airport. Said scope of work shall include:

- * Apron Reconstruction
- * Concrete Apron Repair
- * Apron Overlay
- * Storm Drain Improvements
- * Seal Coat
- * Fuel Tank Removal
- * Additive Alternate i - Sealcoat and Marking

CONTRACT DOCUMENTS

The Completed CONTRACT between the parties hereto shall consist of the following identified documents, herein referred to as the Contract Documents; Notice to Bidders, (Advertisement for Bids), Instruction to Bidders, Bid Form, this Agreement, Bid Bond, Performance Bond, Labor and Materials Bond, Plans, and Specifications and addenda thereto.

CONTRACT PRICE

The COUNTY agrees to pay and the CONTRACTOR agrees to accept, in full payment for the full and complete performance of the CONTRACT, the sum of Four Hundred Twenty-Four Thousand One Hundred Seventy-Nine Dollars and Twenty-Five Cents (\$424,179.25) subject to additions and deductions as provided for in the Contract Documents.

TIME OF COMPLETION

The time of completion for the project is thirty (30) calendar days. The per diem rate for liquidated damages shall be \$500.00.

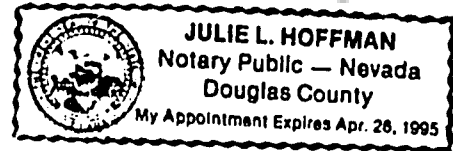
