13 COMES NOW BONNIE F. SARASOLA, as executrix of the estate of
14 BERYL D. RASMUSSEN, deceased, and proves to the satisfaction of
15 the Court that her First and Final Account of Executrix, Report
16 of Administration, and Petition for Final Distribution was
17 rendered and filed on May 7, 1984, and the same regularly
18 coming for hearing before the Court, notice having been
19 dispensed with by MRS 145. 050, and no person appearing to
20 except or contest the said Account or Petition, the Court,
21 after hearing the evidence, finds that notice to creditors has
22 been given in the manner and for the period prescribed by law;
23 that all of the allegations of said Petition are true; that all
24 claims presented against said estate have been approved and paid,
25 and that all expenses of administration, including attorney's
26 fees and fees of the executrix, and costs incurred, have been
27 paid; and that said Account should be settled and distribution
28 of the estate of said decedent, now in the hands of the executrix,
29 should be made as prayed for.

30 IT IS THEREFORE ORDERED, ADJUDGED AND DECREED that the
31 First and Final Account, Report of Administration, and Petition
32 for Final Distribution heretofore filed herein by the said

1 BONNIE F. SARASOLA, executrix of the estate of BERYL D.
2 RASMUSSEN, deceased, be, and the same is hereby, settled, allowed,
3 and approved.

4 IT IS FURTHER ORDERED, ADJUDGED AND DECREED that, in
5 accordance with the terms of the Last Will and Testament of
6 said decedent, admitted to probate herein, the residue of said
7 estate, now in the hands of the Executrix, together with any and
8 all other assets of said estate that may be hereafter discovered
9 within the State of Nevada, be distributed as follows:

10 1. To STEVEN DALE RASMUSSEN, the sum of \$2,000 to be paid
11 in trust to BONNIE F. SARASOLA, until said STEVEN DALE RASMUSSEN
12 attains the age of thirty (30) years, said BONNIE F. SARASOLA
13 to invest said fund in a prudent manner according to her sole
14 discretion.

15 2. The sum of \$1,483.15 to each named grandchild,
16 as follows: to BONNIE F. SARASOLA in trust for her daughters
17 KELLY MARGARET SARASOLA and JULIE LYNN SARASOLA; to STARLA F.
18 SMITH in trust for her children STEPHANIE DAWN SMITH and SCOTT
19 GERALD SMITH; and to DALENE MILLARD in trust for her daughter
20 KRISTEN MONIQUE MILLARD, until each beneficiary attains the age
21 of twenty-one (21) years, together with \$88.82 to each grandchild
22 to be received monthly pursuant to that certain promissory note
23 secured by deed of trust on Genoa, Nevada, property heretofore
24 recorded in Book 380, Page 902, bearing Document No. 42477,
25 dated March 7, 1980, said total being payable in equal monthly
26 installments of \$444.10.

27 The foregoing sums have been directed pursuant to Paragraph
28 VI of the Last Will and Testament of decedent to be held in trust
29 by the mothers of the respective distributees until each bene-
30 ficiary attains the age of twenty-one (21) years and further
31 authorizes that the trustees shall use the trusts, after consul-
32 tation with the beneficiary, as they deem necessary to provide

1 for the proper support, maintenance, medical care and education
2 of the beneficiary.

3 In consideration of the request set forth in Paragraph
4 VI of the Last Will and Testament of decedent, it is therefore
5 ordered that individual accounts in trust be established by
6 BONNIE F. SARASOLA for her daughters, KELLY MARGARET SARASOLA
7 and JULIE LYNN SARASOLA, and by STARLA F. SMITH for her children,
8 STEPHANIE DAWN SMITH and SCOTT GERALD SMITH, and by DALENE D.
9 MILLARD, in trust for her child, KRISTEN MONIQUE MILLARD, to be
10 funded by the distribution hereinabove set forth together with
11 those certain payments hereinabove called for to be deposited
12 on a monthly basis, and that those accounts be accounted for on
13 an annual basis to this Court, and that none of the funds
14 deposited thereto be distributed without prior approval of this
15 Court, on the basis of these trust accounts being maintained for
16 the benefit of the minor children with a proper accounting to
17 this Court for any distributions thereof.

18 The tenor of this order is for the purpose of avoiding the
19 additional expense of establishing formal Court-administered
20 guardianships for the estates of the children.

21 It is further ordered that each of the trustees hereof
22 account to this Court on an annual basis for the funds received
23 by such trustee and deposited in the trust account for the
24 benefit of each beneficiary during the pendency of the minority
25 of each of the beneficiaries hereof. In that connection, it is
26 hereby ordered that BONNIE F. SARASOLA, executrix herein, is
27 ordered to deposit the distributive share of the account of each
28 beneficiary to a trust account at Valley Bank of Nevada, Minden
29 Branch, for the purpose of the maintenance of said funds in
30 trust.

31 The Court takes note of the fact that the beneficiaries and
32 their trustees under the Last Will and Testament of the decedent

1 acknowledge the inconsistency contained in Paragraph V of said
2 Last Will and Testament wherein there are named five grand-
3 children as beneficiaries and language subsequently appearing
4 in said Paragraph indicates that "each of my said legatees
5 receive one-third of this said sum from the Murray Alstott
6 note payments".

7 It is further ordered, adjudged and decreed that the
8 executrix be, and she is hereby, discharged as such executrix.
