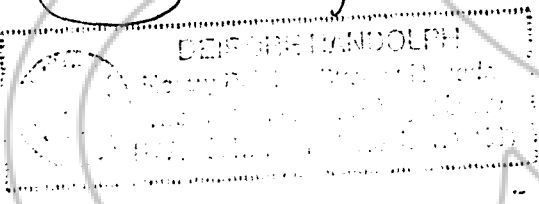

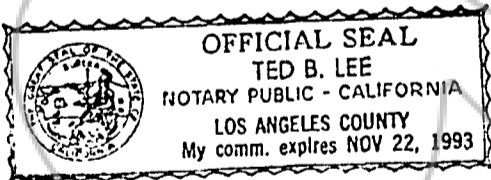

DESCRIPTION
