- 23 1. That the Court has jurisdiction of the parties and
subject matter of this case.
- 24 2. That the defendant was served with the notice of hearing
25 by certified mail.
- 26 3. That the defendant is the parent of the following
27 children:

1 4. That the defendant owes a duty of support to the
2 following dependents:

4 5. That in the parties' divorce decree the defendant was
5 ordered to pay \$75.00 per month per child for a total
6 of \$150.00 per month as ongoing child support.

6 6. That the defendant is in arrears in the amount of
7 \$1,800.00 for the period January, 1990, through
8 and including July 31, 1991.

9 THEREFORE, IT IS HEREBY ORDERED THAT:

9 1. That the defendant is the parent of the following
10 children:

BONNIE J. BRAUN

Born: September 11, 1982

12 2. Judgment is entered in favor of plaintiff TERRY K.
13 KRUSE and against defendant in the amount of
14 \$1,800.00 for arrears for the period January, 1990,
15 through and including July 31, 1991

15 3. That defendant shall pay \$165.00 per month, by wage
16 withholding, to be paid as follows:

19 4. The defendant shall provide health insurance coverage for
20 his minor children, if available to him at a reasonable
21 cost or at a reasonable cost through his employment.

21 5. The defendant shall notify the Douglas County District
22 Attorney's Office of any change in home address, mailing
23 address, telephone number, or employment, within ten
24 days of any change.

24 6. It is further ordered that:

25 (1) Defendant's first monthly child support
26 obligation shall be due on the 30th day of August,
27 1991, and shall continue due on the last day of each
28 and every month thereafter until further order of
this court.

(2) That when defendant's minor children
emancipates, defendant shall continue to pay \$150.00
per month toward satisfaction of then

1 existing child support arrears in accordance with
NRS 125B.100.

2 (3) That defendant's ordered monthly payment on
child support arrearages does not preclude other
3 methods of collection for child support arrears.

4 (4) This support order shall be reviewed every
three years in accordance with NRS 125B.145.

5 (5) That defendant's monthly child
support payments shall be in the form of a
6 cashier's check, certified check, or money order,
or in cash. If the payment is in the form of cash,
7 it must be delivered to the Douglas County Clerk at
her office in Minden, Nevada. If the payment is in
8 the form of a cashier's check, certified check, or
money order, it must be made payable to the
9 DOUGLAS COUNTY CLERK, must contain the notation
Case No. 910116 (BRAUN), and be either mailed to
10 the Douglas County Clerk at Post Office Box
218, Minden, Nevada 89423, or delivered to said
11 County Clerk at her office in Minden,
Nevada. The Douglas County Clerk shall
12 transmit said payments to: TERRY K. KRUSE.
