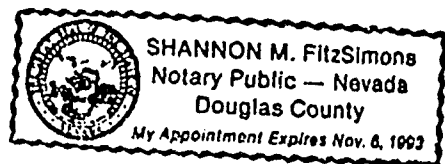


Dear Mr. Doyle:
