singular number includes the plural.

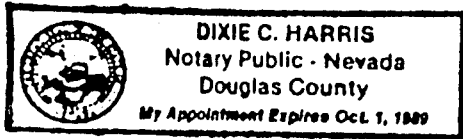

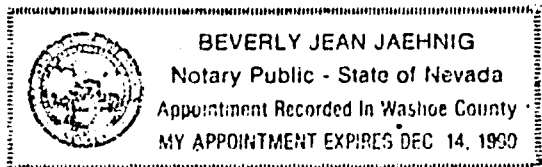

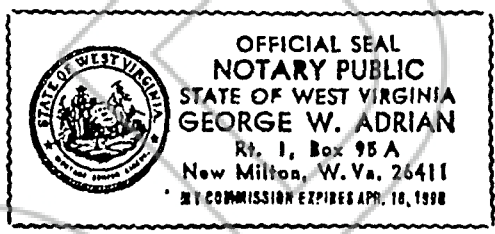
