4. ✓ The defendant shall notify the Douglas County District Attorney's Office of any change in home address, mailing address, telephone number, or employment, within ten days of any change.

5. ✓ It is further ordered that:

(1) Defendant's first monthly child support reimbursement payment shall be due on the 15th day of September, 1991, and shall continue due on the 15th day of each and every month thereafter until further order of this court.

(2) That defendant's ordered monthly payment on child support arrearages does not preclude other methods of collection for child support arrears.

(3) That defendant's monthly child support reimbursement payments shall be in the form of a cashier's check, certified check, or money order, or in cash. If the payment is in the form of cash, it must be delivered to the Douglas County Clerk at her office in Minden, Nevada. If the payment is in the form of a cashier's check, certified check, or money order, it must be made payable to the DOUGLAS COUNTY CLERK, must contain the notation Case No. 910111 (CARMAN), and be either mailed to the Douglas County Clerk at Post Office Box 218, Minden, Nevada 89423, or delivered to said County Clerk at her office in Minden, Nevada. The Douglas County Clerk shall transmit said payments to: Washington State Support Registry, P.O. Box 9162, MS HJ-31, Olympia, WA 95804.

2 payments in arrears by 30 days may be withheld from income  
3 without further order of any court or further application
