The TOWN also is analyzing cost sharing with developers of proposed water quality improvements, which share of costs will be determined based upon the runoff potential and area of property.
- The TOWN and DEVELOPER agree that the TOWN has established a maximum cost sharing amount for the DEVELOPER's property of \$2,179.29, which funds would be utilized for the proposed sand and oil interceptor, drop inlets, drain pipe, wet land enhancement, easement acquisition and/or related water quality improvements when the Subarea Drainage Plan is developed and implemented.
- The TOWN and DEVELOPER agree that the drainage and water quality improvements contemplated by the TOWN will enhance the area of the TOWN in which the DEVELOPER's property situated. is Based upon the advantages of comprehensive Subarea Drainage Plan being implemented, DEVELOPER
