22 AFTER CONSIDERING ALL OF THE EVIDENCE, THE COURT FINDS:

- 23 1. ✓ That the defendant was served with the notice of hearing by certified mail.
- 24 2. ✓ That the defendant is not obligated to pay ongoing child support because he has custody of his minor child.
- 25 3. ✓ That the defendant is the parent of the following children:

- 28 4. ✓ That the defendant has agreed by stipulation that this

1 court may enter an order against defendant and in favor
2 of Nevada State Welfare Division reducing to judgment
3 the sum of \$1,431.00 for welfare reimbursement for the
4 period September, 1990, through and including June, 1991.

5. The Court further finds that:

6 (1) The parties have a divorce case pending in
7 Carson City, Nevada, and there is a hearing
8 scheduled for February 7, 1991. There are questions
9 regarding custody of the parties' minor child during
10 the period of time for which welfare reimbursement
11 is sought.

12 THEREFORE, IT IS HEREBY ORDERED THAT:

13 1. That the defendant is the parent of the following
14 children:

15 DERRICK DANNENFELSER Born: March 19, 1986

16 2. Judgment is entered in favor of Nevada State Welfare
17 Division and against defendant in the amount of
18 \$1,431.00 for welfare reimbursement for the period
19 September, 1990, through and including June, 1991.

20 3. This case shall be heard in March, 1992, for the purpose
21 of determining the exact amount of reimbursement owed
22 by Defendant to Nevada State Welfare Division in
23 accordance with the parties' divorce decree, and to
24 determine a monthly payment to be made by defendant
25 toward satisfaction of reimbursement owed.
