

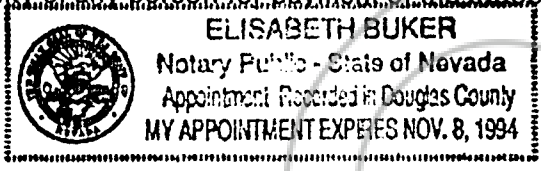
Partial Reconveyance
