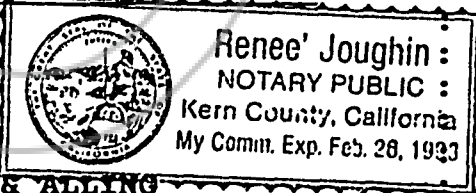

All that portion of the Northwest quarter of Section 29, Township 13 North, Range 20 East, M.D.B. & M., particularly described as follows:

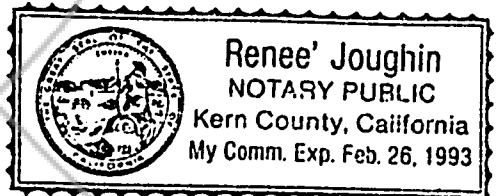
