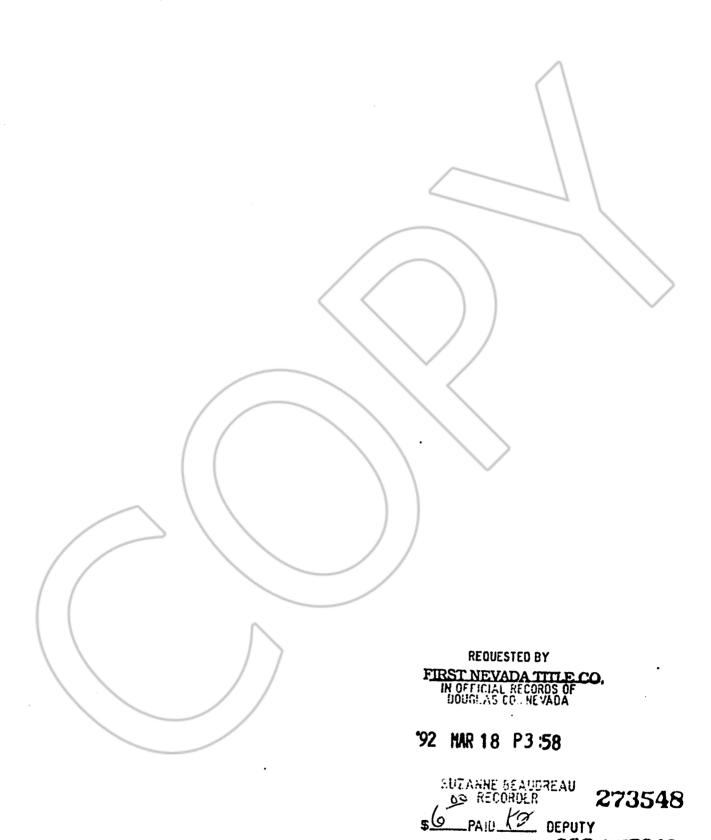

DEED OF TRUST WITH ASSIGNMENT OF RENTS

WILLSON, A MARRIED MAN AS HIS SOLE AND SEPARATE PROPERTY , BENEFICIARY, WITNESSETH: That Trustor grants to trustee in trust, with power of sale, that properly in the , State of NEVADA described as: . IN BLOCK A, AS SHOWN ON THE OFFICIAL PLAT OF DOWNTOWN GRIZ SUBDIVISION, FILED FOR RECORD IN THE OFFICE OF THE DOUGLAS COUNTY RECORDER, ON OCTOBER 7, 1991, AS DOCUMENT NO. 262042, OFFICIAL RECORDS. ASSESSOR'S PARCEL NO. 27-691-04 IN THE EVENT THE TRUSTOR SELLS, CONVEYS OR ALIENATES THE WITHIN DESCRIBED REAL PROPERTY OR CONTRACTS TO SELL, CONVEY OR ALIENATE; OR IS DIVESTED OF TITLE IN ANY OTHER MANNER WITHOUT THE APPROVAL OF AN ASSUMPTION OF THIS OBLIGATION BY THE BENEFICIARY BEING FIRST OBTAINED, BENEFICIARY SHALL HAVE THE RIGHT TO DECLARE THE UNPAID BALANCE DUE AND PAYABLE IN FULL, IRRESPECTIVE OF THE MATURITY DATE EXPRESSED ON THE NOTE SECURED HEREBY PANELA G. WILLSON, WIFE OF BENEFICIARY JOINS IN THE EXECUTION OF THIS DEED OF TRUST TO DIVEST ANY INTEREST THAT SHE MAY HAVE IN THIS DEED OF TRUST OR PROPERTY HEREIN DESCRIBED. Together with the rents, issues and profits thereof, subject, however, to the right, power and authority hereinafter given to and conferred upon Boneficiary to collect and apply such rents, issues and profits. For the purpose of securing (1) payment of the sum of \$ 100,000.00 with interest thereon according to the terms of a promissory note or notes of even date herewith made by Trustor, payable to order of Beneficiary, and all extensions or renewals thereof; and (2) the performance of each agreement of Trustor incorporated herein by reference or contained herein; (3) payment of additional sums and interest thereon which may hereafter be loaned to Trustor, or to his successors or assigns, when evidenced by a promissory note or notes reciting that they are secured by this Dood of Trust.
