DECLARATION OF HOMESTEAD


That the homestead herein declared is the principal dwelling of the declared homestead owners;

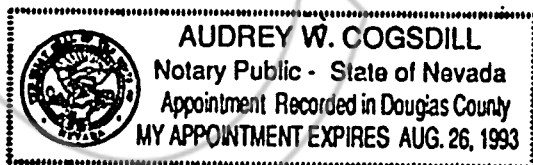
