

NOTICE OF DEFAULT AND ELECTION TO SELL

Notice is hereby given that XANADU CUSTOMHOMES, LTD and PETER ENNS, hereinafter referred to as "Debtor", of 1009 10TH CONCESSION, CANADA, LOR 1KO is indebted to World Class Resorts International, Inc., hereinafter referred to as "Club", a Nevada Not For Profit Corporation, in the amount of \$ 148.35 which represents the balance owing for non-payment of duly levied annual dues and/or other assessments on a certain membership in "Club", as described herein. 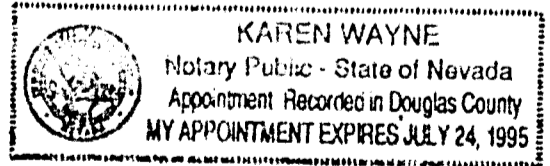
