

NOTICE OF DEFAULT AND ELECTION TO SELL

Notice is hereby given that AMADOR CRIADO and WILMA CRIADO, hereinafter referred to as "Debtor", of RR#2 P.O. 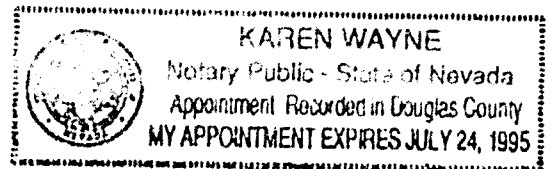
