

NOTICE OF DEFAULT AND ELECTION TO SELL

Notice is hereby given that MICHELLE TURNER and STEPHEN BARNES, hereinafter referred to as "Debtor", of 94 ST. 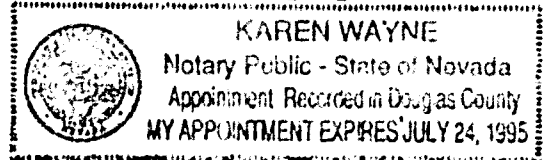
