- 6. Defendant understands that a wage withholding will be initiated by plaintiff without further notice to defendant if he becomes 30 days delinquent in his child support obligation.
- 7. Defendant understands that his ordered \$50.00 monthly payment toward satisfaction of reimbursement owed does
