STIPULATION

11 DAVID C. DANNENFELSER,

13 IT IS HEREBY AGREED between Plaintiff DEBRA M.

14 DANNENFELSER and Defendant DAVID C. DANNENFELSER, by and through
15 their undersigned legal counsels that this Court may enter an
16 order in accordance with the terms of this stipulation.

17 1. Defendant and plaintiff agree that this Court may
18 enter an order requiring defendant DAVID C. DANNENFELSER to pay
19 \$50.00 per month toward satisfaction of welfare reimbursement
20 owed to Nevada State Welfare Division in the amount of
21 \$1,431.00, which was reduced to judgment by this Court on
22 December 24, 1991.

23 2. Defendant understands that the plaintiff DEBRA
24 DANNENFELSER will repay him in accordance with the parties
25 divorce decree entered February 27, 1992.

26 3. Defendant understands that he shall make his
27 reimbursement payments in the form of a cashier's check,

1 certified check, or money order, or in cash. Defendant further
2 understands that if the payment is in the form of cash it must
3 be delivered to the Douglas County Clerk at her office in
4 Minden, Nevada. If the payment is in the form of a cashier's
5 check, certified check, or money order, Defendant understands
6 that it must be made payable to the DOUGLAS COUNTY CLERK, with
7 the notation Case No. 910108 (DANNENFELSER), and be either
8 mailed to the Douglas County Clerk at Post Office Box 218,
9 Minden, Nevada 89423, or delivered to said County Clerk at her
10 office in Minden, Nevada. The Douglas County Clerk shall
11 transmit said payments to: Carson City District Attorney,
12 Family Support Division, 303 North Curry Street, Carson City,
13 NV 89703.

14 4. Defendant and plaintiff agree that this court may
15 enter an order requiring defendant to notify the Douglas County
16 District Attorney's Office in writing within 10 days of any
17 change in defendant's mailing address, home address, or
18 employment.

19 5. Defendant understands that the order and judgment
20 entered in accordance with this stipulation will be recorded
21 with the Douglas County Recorder's Office as a lien against real
22 property in accordance with NRS 17.150.

23 6. Defendant understands that a wage withholding will
24 be initiated by plaintiff without further notice to defendant if
25 he becomes 30 days delinquent in his child support obligation.

26 7. Defendant understands that his ordered \$50.00
27 monthly payment toward satisfaction of reimbursement owed does
28

1 not preclude other methods of collection for child support
2 arrears.
