IT IS HEREBY AGREED between plaintiff LANGE BURNETT

15

and defendant JEFFREY E. KIRBY, by and through their undersigned

16

legal counsels, that this court may enter an order in accordance

17

with the terms of this stipulation.

18

1. Defendant and plaintiff understand that at the

19

hearing on January 31, 1992, the Court rescinded the

20

Administrative Hearing Officer's Recommendations entered April

21

11, 1991.

22

2. Defendant and plaintiff agree that, in accordance

23

with NRS 125B.070, \$312.00 is an appropriate amount of ongoing

24

support for defendant to pay. Defendant and plaintiff

25

understand that this amount reflects a credit of \$33.50 per

26

month which defendant pays for medical insurance for his minor

27

child CHLOE ALEXIS KIRBY-BURNETT.

1           3. Defendant and plaintiff agree that this Court may  
2 enter an order requiring the defendant to pay \$312.00 per month  
3 as ongoing child support.

4           4. Defendant and plaintiff agree that the defendant  
5 has accrued child support arrears in the amount of \$1,972.86  
6 through and including February 25, 1992.

7           5. Defendant and plaintiff agree that this Court may  
8 enter an order in favor of plaintiff and against defendant  
9 reducing to judgment the sum of \$1,972.86 as child support  
10 arrears, and requiring defendant to pay \$50.00 per month toward  
11 satisfaction thereof.

12           6. Defendant and plaintiff agree that this Court may  
13 enter an order requiring the defendant to continue to provide  
14 medical insurance for his minor child CHLOE ALEXIS  
15 KIRBY-BURNETT, and requiring the defendant to provide an  
16 insurance card, claim forms, and other information requested to  
17 the District Attorney's Office for submittal to the plaintiff.

18           7. Defendant understands that his first \$362.00 child  
19 support and arrears payment is due on the 30th day of March,  
20 1992, and shall continue due on the last day of each and every  
21 month thereafter until further order of this Court.

22           8. Defendant understands that a wage withholding will  
23 be initiated by plaintiff without further notice to defendant if  
24 he becomes 30 days delinquent in his child support obligation.

25           9. Defendant understands that all child support  
26 payments to be made by him to plaintiff must be in the form of a  
27 cashier's check, certified check, or money order, or in cash.  
28 The defendant further understands that if the payment is in the

1 form of cash it must be delivered to the Douglas County Clerk at  
2 her office in Minden, Nevada. If the payment is in the form of  
3 a cashier's check, certified check, or money order, Defendant  
4 understands that it must be made payable to the DOUGLAS COUNTY  
5 CLERK, with the notation Case No. 880119 (KIRBY), and be either  
6 mailed to the Douglas County Clerk at Post Office Box 218,  
7 Minden, Nevada 89423, or delivered to said County Clerk at her  
8 office in Minden, Nevada.

9 10. Defendant agrees that this court may enter an  
10 order requiring defendant to notify the Douglas County District  
11 Attorney's Office in writing within 10 days of any change in  
12 defendant's mailing address, home address, or employment.

13 11. Defendant understands that this support order  
14 must be reviewed every three years in accordance with NRS  
15 125B.145.
