AGREEMENT FOR EXTENSION

This agreement is made on March 1, 1992, between the Douglas County Courts Design & Planning Team, <sup>BARBARA REED</sup> ~~Barbara Reed~~, Chairperson, of Douglas County, Nevada, (Courts) and Soni C. Meckem of Jackson Hole, Wyoming and Joseph C. Jordan of San Rafael, California, independent consultants (Consultants).

R E C I T A L S :

The Courts, being satisfied with the past performance of the Consultants, desire to extend and modify the agreement dated March 2, 1989, which expires on March 1, 1992.

The Consultants are willing to enter this agreement to extend their professional services upon the terms and conditions of this agreement and on the March 2, 1989 agreement.

In consideration of the mutual covenants contained in this agreement, it is agreed by the parties as follows:

I. Term and extension.

The employment of the Consultants shall continue under the terms of the March 2, 1989, agreement and shall be extended up to twenty-four (24) months to commence on March 1, 1992. This term may be extended by written agreement of the parties.

II. Duties and scope of services.

The duties and scope of services to be performed by the Consultants and Courts are shown in Exhibit "A", of the March 2, 1989 agreement to the extent they have not already been completed by the parties.

III. Compensation.

Consultants shall be compensated for this extension, which amends and replaces the compensation portion of the March 2, 1989 agreement and Exhibit "B", in an amount not to exceed \$48,000.00, individually, for the twenty-four month period. Soni C. Meckem will receive a monthly payment in the amount of \$2,000.00 per month to be paid on the 1st of every month. Joseph C. Jordan will receive \$50.00 per hour for compensation and will bill the county on a monthly basis. Expenses will be reimbursed according to the March 2, 1989, agreement.

IV. Conflict.


The parties intend this amendment to control if there is a conflict between its provisions and the March 2, 1989, agreement.


V. Entire agreement.

This document constitutes the entire agreement between the parties and there are no other agreements implied or expressed regarding the extension.
