The Court finds presumed child support of \$397, plus \$58 child care expenses and spousal support of \$398, for a total payment by husband to wife of \$854, based on gross income of husband of \$2,960, of wife of \$1,358, with 50% parentime time to each, based on a 20% formula for presumed child support, and child care of \$120 per month paid to wife. The Court further orders a 8332 release from mother to father. The support orders are made efective as of February 15, 1991, and payable on the 15th day of each month, with the first payment due February 15, 1991. The Court will allow husband to pay the current support, plus \$150 per month on arrearages, with the first payment due April 15, 1991.

As to the issue of attorney fees, because the wife will have a greater spendable income than the husband, the Court will not award attorneys fees and costs at this timme. The Court will reserve the issue of attorney fees and costs to the time of trial.
