

# SUBSTITUTION OF TRUSTEE AND DEED OF RECONVEYANCE

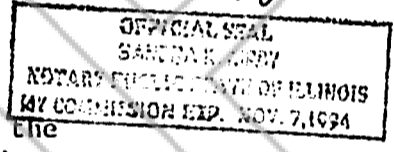
The undersigned, FRANK E. GLENN AND MARILYN E. GLENN, HUSBAND AND WIFE

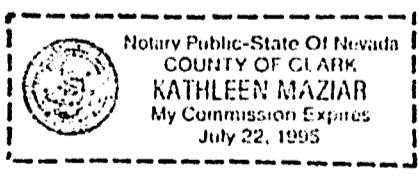
