

NOTICE OF DEFAULT AND ELECTION TO SELL

NOTICE IS HEREBY GIVEN THAT:

STEPHEN J. ALLEN and JAMI R TRUEMAN, hereinafter referred to as "Debtor", of P.O. 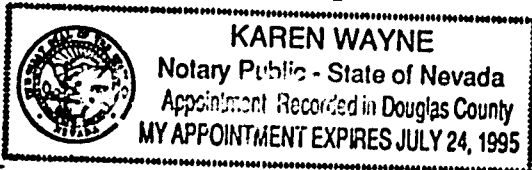
