10 WHEREFORE, by virtue of the law and by reason of the
11 premises aforesaid,

12 IT IS HEREBY ORDERED, ADJUDGED, and DECREED that the
13 Plaintiffs have and recover from the Defendant the sum of TWO
14 THOUSAND, TWO HUNDRED SIXTY-TWO AND 31/100 DOLLARS (\$2,262.31),
15 together with interest thereon at the rate of TWELVE PERCENT (12%)
16 per annum on the total Judgment amount from the date of service of
17 the Summons and Complaint upon Defendant (i.e., April 20, 1992) in
18 the accrued amount of \$52.81 as of June 30, 1992 and at the daily
19 rate of \$.74 until the date of Judgment; for costs of suit in the
20 sum of ONE HUNDRED TWENTY-SIX AND 54/100 DOLLARS (\$126.54); for
21 postjudgment interest at the rate permitted by statute; and for a
22 reasonable attorney fee in the amount of \$ 500.⁰⁰ .
