1 1. That the First and Final Account of PIERCE E. TULLY, as
2 Executor of the estate of DOROTHY M. TULLY, deceased, be, and the
3 same is, hereby finally settled, allowed and approved, and all
4 actions taken by the Executor in connection with the administration
5 of the estate as set forth in the account and petition filed herein
6 on the 14th day of September, 1992, are hereby ratified and approved.

7 2. That the Executor is hereby authorized and directed to pay
8 from the funds of the estate attorney's fees in the amount of
9 \$3,250.00 and costs in connection with this estate matter of \$716.20
10 (\$3,966.20 total) to Nathan M. Jenkins, Esq. for services rendered
11 and costs advanced in this estate.

12 3. That in accordance with ARTICLE IV of the decedent's Will
13 the said Executor is hereby authorized and directed to distribute the
