Short Form of Mining Lease dated as of ("Effective Date") between G. & S.R. SPRINGMEYER CO., a Nevada corporation having a mailing address at P.O. Box 280, Minden, Nevada 89423 ("Owner") and HOMESTAKE MINING COMPANY OF CALIFORNIA, a California corporation having its principal place of business at 650 California Street, San Francisco, California 94108 ("Lessee").

- Lease and Term. (a) Owner leases to Lessee all of the fee lands described in Parts I and II of Exhibit A ("Ranch Lands") and all of the unpatented mining claims described in Parts III and IV of Exhibit A ("Claims") (the Ranch Lands and the Claims are hereafter referred to collectively as the "Mining Property"), together with all (i) tailings, dumps and mine wastes on the Mining Property, (ii) surface rights, easements and rights of way incident or appurtenant to the Mining Property, (iii) mining and mineral rights incident or appurtenant to the Mining Property, (iv) water rights incident or appurtenant to the Mining Property but subject to the terms of the Agricultural Lease described in Section 6(c) for so long as such Agricultural Lease shall remain in effect and (v) improvements, fixtures, personal property, mining machinery, wells, pipelines and tools on the Mining Property that are or may be useful or convenient for mining, milling and beneficiation of ores and minerals and related uses on the terms and conditions set forth in this agreement, but not including the horse project facilities or any of the equipment or personal property covered by the Agricultural Lease.
