

QUITCLAIM DEED

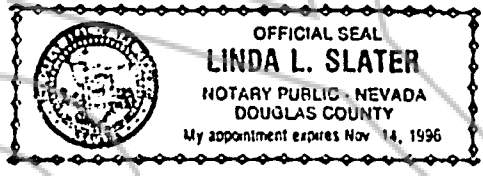
