ORDER AND JUDGMENT

AFTER CONSIDERING ALL OF THE EVIDENCE, THE COURT FINDS:

1. That the Court has jurisdiction of the parties and subject matter of this case.
2. That the defendant was personally served with the summons and complaint on September 18, 1992.
3. That the defendant is the parent of the following children:

JOHN B. COMEAU Born: 10/22/87
CHANTELLE M. COMEAU Born: 08/01/90

1 4. ✓ That the defendant owes a duty of support to the following dependents:

2 JOHN B. COMEAU Born: 10/22/87
3 CHANTELLE M. COMEAU Born: 08/01/90

4 5. ✓ That 25% of defendant's gross income, for a total of \$374.13 per month is a reasonable amount of ongoing child support for defendant to pay in accordance with NRS 125B.070.

6 6. ✓ That the defendant owes child support arrears to plaintiff in the amount of \$1,122.39 for the period September, 1992, to and including November 30, 1992.

8 THEREFORE, IT IS HEREBY ORDERED THAT:

9 1. ✓ That the defendant is the parent of the following children:

10 JOHN B. COMEAU Born: 10/22/87
11 CHANTELLE M. COMEAU Born: 08/01/90

12 2. ✓ Judgment is entered in favor of plaintiff ELIZA D. COMEAU and against defendant in the amount of \$1,122.39 for arrearages for the period September, 1992, through and including November 30, 1992.

13 3. ✓ That defendant shall pay \$411.54 per month, by wage withholding, to be paid as follows

14 4. ✓ The defendant shall provide health insurance coverage for his/her minor children, if available at a reasonable cost or at a reasonable cost through his/her employment.

15 5. ✓ The defendant shall notify the Douglas County District Attorney's Office of any change in home address, mailing address, telephone number, or employment, within ten days of any change.

16 6. ✓ It is further ordered that:

17 (1) Defendant's first monthly child support obligation shall be due on the 1st day of January, 1993, and shall continue due on the 1st day of each and every month thereafter until further order of this court.

18 (2) That when defendant's minor child(ren) emancipate(s), defendant shall continue to pay

1 \$374.13 per month toward satisfaction of then
existing child support arrears in accordance with
NRS 125B.100.

2 (3) That defendant's ordered monthly payment on
child support arrearages does not preclude other
3 methods of collection for child support arrears.

4 (4) This support order shall be reviewed every
three years in accordance with NRS 125B.145.

5 (5) That defendant's monthly child
support payments shall be in the form of a
6 cashier's check, certified check, or money order,
or in cash. If the payment is in the form of cash,
it must be delivered to the Douglas County Clerk at
7 her office in Minden, Nevada. If the payment is in
the form of a cashier's check, certified check, or
8 money order, it must be made payable to the
DOUGLAS COUNTY CLERK, must contain the notation
9 Case No. 920150 (COMEAU), and be either mailed to
the Douglas County Clerk at Post Office Box
10 218, Minden, Nevada 89423, or delivered to said
County Clerk at her office in Minden,
11 Nevada. The Douglas County Clerk shall
transmit said payments to: EL DORADO COUNTY DISTRICT
12 ATTORNEY, FAMILY SUPPORT DIVISION, P.O. BOX 1045,
PLACERVILLE, CA 95667 (Case No. 24360).

14 7. X NOTICE: This is an income withholding order. Support
15 payments in arrears by 30 days may be withheld from income
without further order of any court or further application
16 for services.
