### DEED OF CORRECTION

This deed of correction made on the 22 day of December, 1992, by DONALD T. 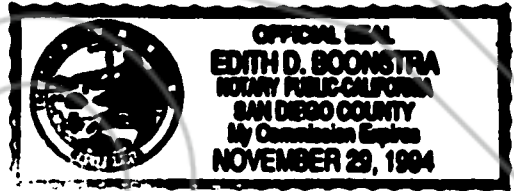
