and 97/100 * * * * * * DOLLARS (\$ 438.97 * *);

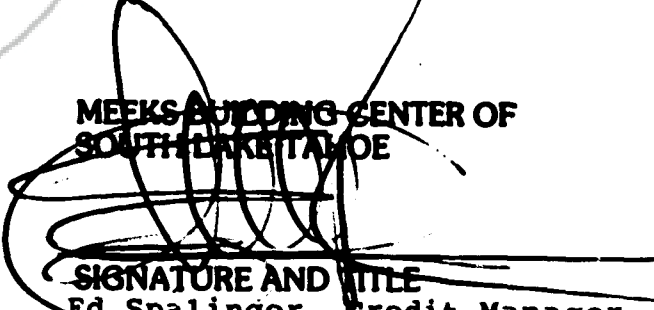
that claimant had demanded and does now demand the payment thereof; that all of said material was

and serving this lien.

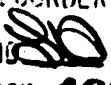
