

SUBSTITUTION OF TRUSTEE

WHEREAS, on April 18, 1988, Philip L. Spadini and Mary E. 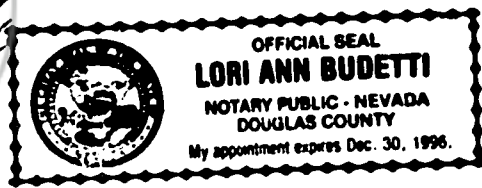

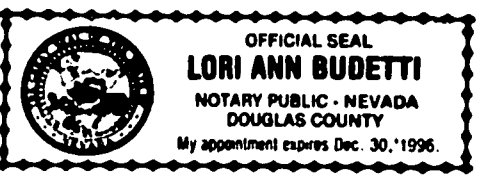
