
RICHARD D. VEAL and MARJORIE J. VEAL, husband and wife,

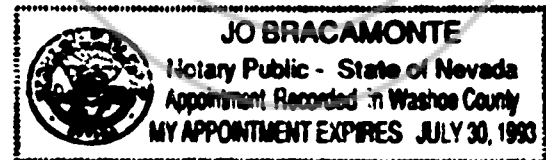
